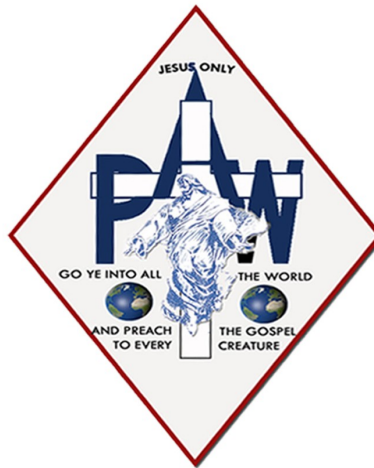

GENERAL SESSION MINUTES

Monday – July 31, 2017

Call to Order The 2017 Pentecostal Assemblies of the World, Inc. Summer Business Session was called to order at 3:07 p.m. by the 2nd Assistant Presiding Bishop Theodore Brooks.

Prayer & Scripture Prayer was offered by Bishop Billy Newton
Scripture: Psalms 24:1-10 – Bishop Gary Harper.

Welcome / Bishop Sherman Merritt Presiding Bishop Ellis called the host bishop, the Honorable Bishop and First Lady Merritt to greet and welcome the delegates to Nashville, TN

Presiding Bishop Charles H. Ellis Bishop Ellis gave opening remarks and welcomed the delegates to the 102nd PAW Summer Convention. Bishop Ellis informed the body that since our last convention the PAW has lost 2 bishop's: Bishop Cecil Pratt, Springfield, OH and Bishop Michael Garrett, San Bernardino, CA. Bishop Ellis attended both home goings and stated that both were well attended and both families were pleased with the outpour of love and support. The Presider called for a moment of silence to honor

them.

Bishop Ellis recognized the Executive Board Officers and Bishops.

Call for Division of the House

Bishop Ellis called for a division of the house, however, he said it was not necessary for anyone to move. Everyone is on the honor system.

Reading of the Minutes from Wednesday, August 3, 2016 – Kansas City, MO

Bishop Ellis called for the reading of the minutes.

On Motion to suspend the reading of the minutes. **Motion Carried**

Departed Saints Forms

Bishop Ellis called for the General Secretary to give instructions on the Dearly Departed Saints Forms. Suffragan Bishop Golder gave instructions to the house. The forms were distributed to the house to be turned in at the end of the business session. Other forms will be available in the General Secretary's Office. The listings will be processed and the names will be read aloud in the Wednesday Business Session.

Committee Appointments

Bishop Ellis called for Pastor Kandy Morrell to represent the chairman of the Resolutions Committee, Suffragan Bishop Paul Evans. Bishop Ellis informed the house to turn in resolutions to Sister Kandy Morrell. The Resolutions Committee prefers all resolutions be typed before submitting.

If so, the first one will be abbreviated and the second one will be the main service. The final decision will be made on Wednesday. The attire will be white. The Executive Board will wear black suits, white shirts and red ties.

**Live Telecast &
Special Offering**

Bishop Ellis gave appreciation to Mr. Kevin Adell, the owner of The Word Network. Bishop Ellis stated that the Word Network has been very gracious to the PAW by donating the live telecast free of charge for the last 7 years. The services will be broadcast "live" this Thursday Night at 8 p.m. EST (which is 7 p.m. CST).

Bishop asked the house to please be on time for the service prior to the start of the live telecast so that we may give offering before the telecast goes on live. Bishop Ellis informed the house that most Bishops have given their offering of \$3000.00 and Executive Board Members \$1500.00 already. He had those who had given to stand.

Bishop Brooks called for Elder Burroughs to give more information. He gave the theme of "ONE GOD, ONE PEOPLE, ONE VOICE". He stated that there are commitments from other Apostolic Organizations such as: UPC, AOH, United Church of Jesus, COOLJC, PCAF, Bibleway Worldwide and Bibleway and other major Apostolic organizations. It will be held May 4, 2018.

Bishop Ellis mentioned that he forgot to include Bishop Robert A. Wauls of Texas who had passed since the last convention. He was 103 and still pastoring four churches.

The Presider informed the body that Mother Gloria Foster passed on last night. She was the mother of Bishop Lance Foster and Lay Director, Suffragan Bishop Lee A. Tolbert's mother in law.

Bishop Ellis welcomed the new officers to the dias. The General Secretary Suffragan Bishop Donald Golder has been elevated to Bishop and the Assistant General Secretary, Suffragan Bishop James G. Rodges has been elevated to Bishop. To fill those unexpired term of General Secretary is Suffragan Bishop Craig High. Suffragan Bishop Ann Story-Pratt was elected Assistant General Secretary by the Executive Board. Suffragan Bishop Leon Parker was elected as the new Assistant General Treasurer.

Bishop Ellis reminded the members that if you want to run for office, you will need to complete the training sessions provided by the Transformational Leadership Department. You must have the certification in order to run for office in this organization.

Treasurer Report

Bishop Ellis asked for the report from the Treasurer. Suffragan Bishop Maxie Dobson gave remarks of explanation before presenting the report.

He then directed everyone's attention to the report.

Bishop Ellis opened the floor for comments or questions.

Question – regarding the net asset and can they be liquidated?

Executive Summary

**“...thanks be unto God, which giveth us the victory...”
(I Corinthians 15:57)**

Sunday School students know that the Apostle Paul used the above words in a specific context, however, we subscribe to them to reflect upon how the Lord blessed our 2016 Convention to realize a repeat of 2015, as relates to the bottom line, “**very black**” (\$134,836 for 2015 and \$131,000 for 2016). We, the constituency of our beloved “*Pentecostal Assemblies of the World, Inc.*,” allowed the Lord to use us to bring about this much desired outcome. And, because of the Lord’s use of us, we were able to achieve the objective of going beyond just absorbing Convention expenses, but contributing \$12,500, each, to International Missions, Aeon Bible College, and seed to establish a PAW Endowment Fund. (Full year 2016 financials follow).

“...thanks be unto God, which giveth us the victory...”

This 102nd International Convention presents us with an opportunity to surpass last year; “*let’s not allow the moment to pass us by*” (2017’s budget for offerings is \$557,735). On this note, much appreciation is extended to our Executive Board of Bishops and licensed ministers that gave liberally (\$210,415) in pre-Convention giving (a report is in each registration bag—and each attendee is asked to register—that reflects such giving by Council). Because of this, we were able to pay over \$300,000 of Convention related expenditures that were required before arriving here on site, “**...thanks be unto God...**” Let’s now **three-peat!!!**
